**RECEIVERSHIP NOTICE** 

Please take notice that on March 4, 2020, an Order Appointing Temporary Receiver was entered by the Providence Superior Court in the above captioned matter. Said Order appointed Giovanni La Terra Bellina, Esquire, of the law firm Orson and Brusini Ltd. in Providence, Rhode Island as Temporary Receiver (the "Receiver") of Respondent, and specified that said Receiver was to give a Surety Bond in the amount of \$10,000.00, with respect to the faithful performance of the duties conferred upon said Receiver by said Order.

Said Order, the original of which, is on file in the Office of the Clerk of the Providence County Superior Court, and which Order is incorporated herein by reference as if it were set forth in full in this Receivership Notice, contains, inter alia, the following provisions:

- "6. Except as provided in paragraph 7 below, that the commencement, prosecution, or continuance of the prosecution of any action, suit, arbitration proceeding, hearing, or any foreclosure, reclamation or repossession proceeding, both judicial and non-judicial, or any other proceeding, in law or in equity, under any statute or otherwise, against said Respondent or any of its property, in any Court, agency, tribunal or elsewhere, or before any arbitrator or otherwise, by any creditor, stockholder, corporation, partnership or any other person, or the levy of any attachment, execution or other process upon or against any property of said Respondent, or the taking or attempting to take into possession any property in the possession of the Respondent or of which Respondent has the right to possession, or the cancellation at any time during the Receivership proceeding herein of any insurance policy, lease or other contract with Respondent, by any of such parties as aforesaid, other than the Receiver designated as aforesaid, or the termination of telephone, electric, gas or other utility service to Respondent by any public utility, without prior approval thereof from this Honorable Court, in which connection said Receiver shall be entitled to prior notice and an opportunity to be heard, are hereby restrained and enjoined until further Order of this Court.
- 7. The foregoing paragraph does not stay the exercise of rights of a party to a swap agreement, securities contact, repurchase agreement, commodity contract, forward contract or master netting agreement, as those terms are defined in the federal Bankruptcy Code, to the extent that a court would not have the power to stay the exercise if Defendant were a debtor under the Bankruptcy Code.

That a citation be issued to said Respondent, returnable to the Superior Court sitting at Providence, Rhode Island on  $\bigcap$  PCTLG, 2020, at 9:30 a.m. at which time and place this cause is set down for Hearing on the prayer for the Appointment of a Permanent Receiver; that the Clerk of this Court shall give Notice of the pendency of the Petition herein by publishing the annexed Receivership Notice once in The Providence Journal on or before MARCH 20, 2020, so long as the Receiver's
